



Coastal Credit Union Music Park Concert Ticket Giveaway

1. Agreement to Rules:

By entering this Giveaway, you acknowledge that you have read and agree to abide by Coastal Federal Credit Union's ("Coastal Credit Union" or "Coastal" or "Sponsor") Official Rules and decisions, which are fully and unconditionally binding in all respects. Coastal Credit Union reserves the right to refuse, withdraw, or disqualify any entry at any time at its sole discretion. By entering, you represent and warrant that you (i) meet the eligibility requirements; (ii) have complied with, and will continue to comply with all the rules and regulations, terms, and conditions set forth in these Official Rules; (iii) have not perpetrated and will not perpetrate any fraud or deception in connection with the Giveaway; and (iv) have not sought to influence the outcome other than by participating as expressly permitted in these Official Rules. You also agree to accept the decisions of Coastal Credit Union as final and binding as they relate to this Giveaway.

2. Eligibility:

This Giveaway is open both Coastal members and non-members who are legal residents of North Carolina and 21 years or older at the time of entry. Coastal Credit Union employees, volunteers, their spouses, immediate families, and persons living in the same household are not eligible to participate. This giveaway is subject to federal, state, and local laws and regulations and is void where prohibited by law.

3. Raffle Entry Period:

This promotion begins on March 2, 2026 and ends on April 3, 2026.

4. How to Enter:

Eligible entrants can enter by engaging with a Coastal Branch employee and satisfying one of the following:

- Having (or opening) Go Green Checking, Coastal Auto Loan, or a Coastal Home Equity Line of Credit (HELOC). (Membership eligibility required)
- Engaging in a branch conversation about how Coastal can help them bank better
- Providing a referral to Coastal
- Scheduling an appointment with Mortgage, Wealth Management, or Daymark Realty by April 3rd
- For all of the above, a Coastal branch employee will submit an eligible entrant on an entry form.

Incomplete entries or those that do not adhere to the rules or specifications will be disqualified at Coastal Credit Union's sole discretion.

To enter via U.S. Mail, on a 3" x 5" postcard, hand print your name, street address, city, state, zip code, area code and telephone number, and email address (optional) and mail to: Coastal Credit Union, Music Park Ticket Giveaway, PO Box 58429, Raleigh, NC 27658. Limit one entry per person via mail during Giveaway Period. Mail-in entries must be postmarked between March 2nd, 2026 and April 3rd, 2026, and be received by date of drawing. All mail in entries become the Credit Union's property and will not be returned or acknowledged. The Credit Union is not responsible for lost, last, damaged, misdirected or

postage due entries. The Credit Union may grant the right to add additional entries deemed necessary or appropriate under the Official Rules.

5. Prizes:

One (1) winner will receive 2 tickets of their choice to an upcoming concert for the 2026 season at the Coastal Credit Union Music Park. The prize is non-transferable, except to a winner's surviving spouse or estate, and no cash or other prize substitution is permitted except at Coastal Credit Union's discretion. The winner is responsible for all expenses related to the prize, including any local, state, and federal taxes. Odds of winning depend on number of eligible entries received during the Giveaway Period.

6. Selection and Notification of Winner:

At the end of the entry period, one random winner will be selected by drawing under the supervision of Coastal Credit Union. Coastal Credit Union will notify the Winner via their contact information from the entry form by April 23, 2026. As a reminder, Coastal will never ask for your personal information (i.e., account number, SSN). Coastal Credit Union is not responsible for, nor shall have no liability for Winner's failure to receive notices due to email security settings that may cause notifications to be marked as spam or junk email. Nor shall Coastal Credit Union be liable for the Winner's provision of incorrect or otherwise non-functioning contact information. If the Winner 1) fails to claim the prize within [5 days] from the time the award notification was sent by indicating and confirming their name and email, 2) is found ineligible, the prize may be forfeited, and an alternate Winner may be selected. Receipt of the prize by the Winner is upon the condition of compliance with any and all federal, state, and local laws and regulations. **IF THE WINNER VIOLATES ANY OF THESE OFFICIAL RULES, THE WINNER (AT COASTAL CREDIT UNION'S SOLE DISCRETION) WILL BE DISQUALIFIED, AND ALL PRIVILEGES AS WINNER WILL BE IMMEDIATELY TERMINATED.**

9. Terms & Conditions:

Coastal Credit Union reserves the right to modify, suspend, cancel, or terminate the Giveaway in case of non-authorized human intervention, a bug or virus, fraud, or other causes beyond Coastal Credit Union's control. Coastal Credit Union has the right, in its sole discretion, to maintain the integrity of the Giveaway and to void entries for any reason, including, but not limited to, multiple entries from the same user, or the use of bots or other automated processes.

10. Limitation of Liability:

By entering, you agree to release and hold harmless Coastal Credit Union and its affiliates, employees, and representatives from any liability, illness, injury, death, loss, litigation, claim, or damage that may occur,

directly or indirectly, from participation in the Giveaway or from the acceptance, possession, use, or misuse of any prize awarded.

11. Disputes:

This Giveaway is governed by the laws of the United States and the state of North Carolina. As a condition of participating in this Giveaway, you agree that any disputes that cannot be resolved between you and Coastal Credit Union and causes of action arising out of or connected with this Giveaway, shall be resolved individually, without resort to any form of class action, exclusively before a court located in North Carolina.
